ANNEXURE-II

Terms and conditions for Providing Transport vehicle for of EVM Transportation From Gujarat to Udupi

Terms and Conditions:

The Transport vehicle will be used exclusively for government purposes only for transportation of EVMs.

1. The transport operator shall deploy the vehicle with drivers on shift basis in any district of Gujarat State, as indented in the enquiry notification on the date and time as per the Work Order.
2. The vehicle shall have registered in any states of India and should have National Permit.
3. Vehicle should be provided with GPS Facility.
4. The vehicle shall be of very good condition, road worthy. This office reserves right to reject or send back any vehicle which is considered unfit for use. The Employer has all rights to temporarily discard the vehicle at any time, No payment will be made for the discarded duration.
5. This office shall not be responsible for payment of insurance premium, road tax etc., and all other statutory obligations in respect of the vehicle. This office shall reserve the right of verifying any original documents of the vehicle submitted for its use before the vehicle put in to use and at any time during the currency of agreement.
6. All costs of operation, repairs, maintenance fuel and oil lubricants reconditioning, servicing, parking fee out side Head Quarter and other unlimited liability will be born by the travel operator only.
7. In the event of any accident involving the vehicles while they are operating for this office all cost, liability, loading complaints on behalf of the officer claiming compensation from the insurance Companies rests with the transport vehicle operator and they are sole responsible.
8. In case of any break down of the vehicle on duty or on any eventuality the same has to be replaced by another vehicle of same specifications immediately by the transport contractor.
9. The offer includes cost of fuel like diesel, other consumables, driver.
10. The Successful Quotation has to submit **security deposit of Rs. 10,000.00** in the form of F.D.R. drawn on any nationalized bank in favour of the Deputy Commissioner, Udupi at the time of submission of tender. The amount will be refundable at the time of expiry of contract. However, if any of the terms and conditions of the contract are violated the security deposit will be forfeited.
11. The payment will be made on km basis on availability of funds.
12. The undersigned reserves the rights to accept or to reject the offer without giving any reason. The decision of the District Commissioner, Udupi is final in case of any dispute.
13. All the taxes payable to the Government shall be deducted at the source.
